## SCOUT LAKE AREA – RULES & REGULATIONS

THE CITY OF CLATSKANIE RESERVES THE RIGHT TO RESTRICT USE AT ANY TIME DUE TO FIRE SEASON CONDITIONS OR OVERCROWDING. IN ORDER TO PROTECT SCOUT LAKE AS A PRIMITIVE CAMPING AREA. VISITORS MUST OBEY THE FOLLOWING.

1. Scout Lake keys are only to be issued to those with an address within the 97016-zip code.
2. Scout Lake is primarily a day use facility and **closes at 8:00 p.m. daily.**
3. **Overnight Camping** is by permit only and is limited to a maximum of five (5) consecutive days. Campers should observe quiet hours from **10:00 p.m. – 7:00 a.m.**
4. **Campfires** are permitted in camp stoves or fireplaces only, and must be supervised at all times. Campfires must be extinguished before the user(s) leave the Scout Lake Area. At the discretion of the State Forestry Department, fires may be restricted due to high fire hazard conditions.
5. **Alcoholic Beverages** are prohibited.
6. **Visitors must stay within the Scout Lake area** and shall not enter adjoining timberlands or active logging areas.
7. Removal of ALL **debris** and **garbage** is required.
8. **Fireworks** are prohibited.
9. **Motorized vehicles** are only allowed on designated roads and must travel at speeds of ten (10) miles per hour or less.
10. **Weapons** shall not be loaded or discharged at any time.
11. **NO HUNTING** is allowed at Scout Lake or camping for hunting.
12. **Pets** are allowed on leash only. Horses and other large animals are not allowed. Owners are responsible for picking up after their pets.
13. **Access Key** must be returned to Clatskanie City Hall by 5:00 p.m. on the date this permit expires. Each **gate** shall be locked upon **entering** and upon **exiting** by each party.
14. Operation of concessions is not allowed expect by special permission.
15. **Vandalism** or removal of any flora, fauna or park structures is prohibited.
16. **Fishing** is only allowed by valid State of Oregon fishing license and regulations. Catch and release and use of barbless hooks are encourage. The maximum catch per person per day is five (5) fish, 8 inch (8”) minimum length.
17. **ONE** vehicle per permit.
